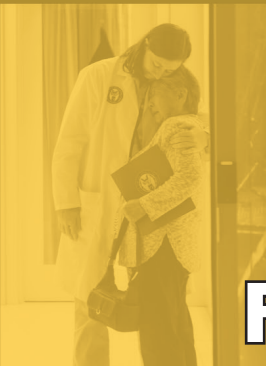

DPAA ACCOUNTS FOR 203 MISSING PERSONNEL IN FISCAL YEAR 2018

In Fiscal Year 2018, the Defense POW/MIA Accounting Agency accounted for 203 formerly missing persons from past conflicts, the highest yearly total reached by the agency or its predecessor organizations. Also, the agency individually identified the remains of three additional personnel, who were previously accounted for as part of group burials.

“Providing the families of the missing those long-sought answers with which they can at least achieve some solace is a profound manifestation of our nation’s steadfast commitment to them and their loved ones,” said DPAA Director Kelly McKeague. “Because it’s a sacred obligation, if not moral imperative, our over 600 military and civilian professionals earnestly contribute their talents, dedication, and passion to the noble mission with which we are entrusted.”

Broken down by conflict, 10 were accounted for from the Vietnam War, 37 from the Korean War, and 156 from World War II.

“Science and technology have expanded exponentially in recent years, enabling identifications that even five years ago seemed impossible,” said Rear Admiral Jon Kreitz, DPAA’s Deputy Director for Operations. “We also attribute the increasing yearly trend to DPAA’s expanded use of partnerships, a more precise management of disinterments, and improvements in our robust field operations.”

DPAA’s partnerships are strong and extensive. First, the government officials and people in each of the countries the agency operates in provide invaluable assistance and respect to the mission. Collaborative support from the four Service Casualty Offices; the Armed Forces Medical Examiner System and the Armed Forces DNA Identification Laboratory; U.S. Indo-Pacific Command, the U.S. European Command and the Defense Intelligence Agency – Stony Beach; the Department of Veterans Affairs and the American Battle Monuments Commission cemeteries are also vital. DPAA’s partnering with non-Federal entities continues to expand agency capacity and capabilities. Additionally, agency efforts benefit from partnerships with family groups and veterans service organizations.

Today, DPAA is focused on the research, investigation, recovery, and identification of the approximately 34,000 (out of approximately 83,000 missing DoD personnel) believed to be recoverable, who were lost in conflicts from World War II to Operation Iraqi Freedom.

Agency Updates

INDO-PACIFIC DIRECTORATE

DPAA's Asia-Pacific Directorate was renamed the Indo-Pacific (IP) Directorate to better represent the region where it is charged with conducting the agency's mission efforts. Although the designation changed, the mission and related work remained the same.

Throughout the fiscal year, IP conducted a total of 19 investigation missions and 34 recovery missions. These efforts spanned the expansive region, sending DPAA military and civilian personnel and DPAA partner organizations to these countries: Vietnam, Laos, South Korea, Kiribati, Philippines, Palau, Papua New Guinea, India, Myanmar, Indonesia, Solomon Islands, Malaysia, and China. IP also conducted a mission in the Commonwealth of the Northern Mariana Islands.

The directorate's work during FY18 also led to the disinterment of 177 caskets of Unknowns from Manila American Cemetery and Honolulu's National Memorial Cemetery of the Pacific.

PARTNERSHIP & INNOVATION DIRECTORATE

Renamed from Strategic Partnerships to better reflect its purpose and scope, DPAA's Partnerships and Innovations (PI) Directorate experienced robust change and growth in FY18. PI has greatly expanded DPAA's external partners, entering into discussions with more than 140 potential partner institutions, leading to the signing of 28 formal Memorandum of Understanding (MOU) agreements with external organizations.

DPAA conducted more than 30 field missions involving partners in FY18, marking a ten-fold increase over FY17. Here is a list of the partners who were involved or are currently involved in these efforts:

- Terrestrial Investigation and Recovery: U. of Wisconsin, Archaeological and Historical Conservancy, U. of Maryland, Shoulder to Shoulder, U. of Queensland, St Mary's U., Cranfield U., U. of Illinois - Chicago, SEARCH, and History Flight.
- Underwater Investigation and Recovery: East Carolina U., U. of Malta, U. of Delaware, Flanders Marine Institute, Institute of Maritime Heritage, Deep Sea Productions, SCRIPPS, Project Recover, and U.S. Navy SPAWAR.
- Surveys and Mission Support: Army Geospatial Command, U. of Warsaw Institute of Archaeology, and U. of New Orleans.

PI also implemented cooperative agreements and grants; expanded the agency's volunteer program; and increased the "hub and spokes" program for historical research, with nine participating institutions: The Ohio State U., Temple U., Texas A&M, U. of Wisconsin, East Carolina U., U. of Southern Mississippi, Brigham Young U., and Tuskegee U. as well as the World War II Museum in New Orleans.



EUROPEAN-MEDITERRANEAN DIRECTORATE

During FY18, DPAA's European-Mediterranean (EM) Directorate conducted 14 investigations (10 organic missions and 4 with partners) and 12 recoveries (7 organic and 5 partnered). These terrestrial and underwater missions were in: Austria, Belgium, France, Germany, Italy, Malta, Poland, Romania, Russia, and the United Kingdom, as well as Alaska.

Disinterments from the European-Mediterranean region also added to the bottom line of the overall DPAA mission, with the lab accessioning 61 remains of Unknowns from disinterments conducted in American Battle Monuments Commission cemeteries throughout Europe.

The European-Mediterranean Joint Commission Support Division (JCSD) planned and participated in a U.S.-Russia Joint Commission on POW/MIAs Plenary Session in Moscow in November 2017; as well as planned, executed, and participated in four Technical Talks: World War II (Moscow, February 2018), Vietnam War (Honolulu, Hawaii, April 2018), Cold War (Vladivostok, Russia, May 2018), and Korean War (Arlington, Virginia, August 2018).

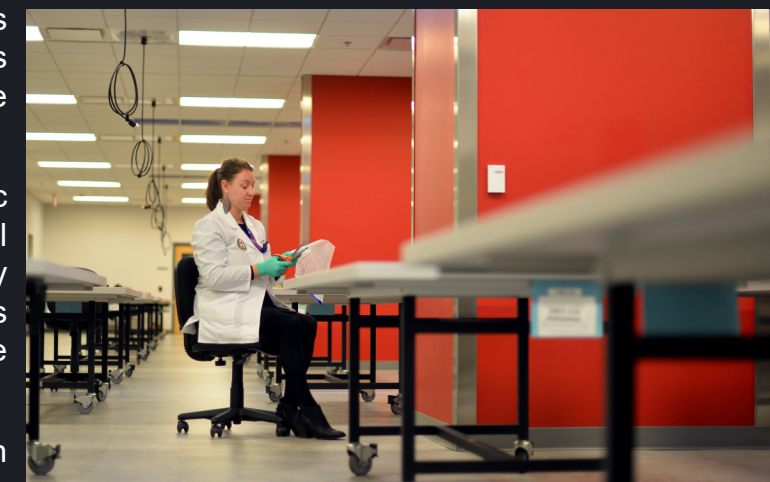
DPAA LABORATORY

DPAA's Laboratory conducted significant work at all three of its locations in FY18. Accessions into the lab totaled 459, which included 239 from disinterments, 126 from unilateral turnovers and 89 from field operations.

The DPAA Lab continued to innovate new methods of data analysis to contribute to expansive projects undergoing analysis. The staff also ramped up stable isotope testing as a new test modality.

During FY18, the lab's international forensic accreditation was renewed by the ANSI-ASQ National Accreditation Board (ANAB). The board's extremely rigorous examination looked at the lab's processes involving anthropology, biology, odontology, trace materials, and scene recovery.

Results from the lab hit a high-water mark in FY18, with a total of 203 previously missing individuals being accounted for. The resolved losses included 10 from the Vietnam War, 156 from World War II, and 37 from the Korean War.

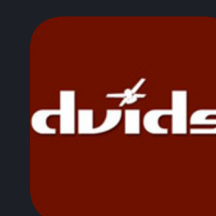

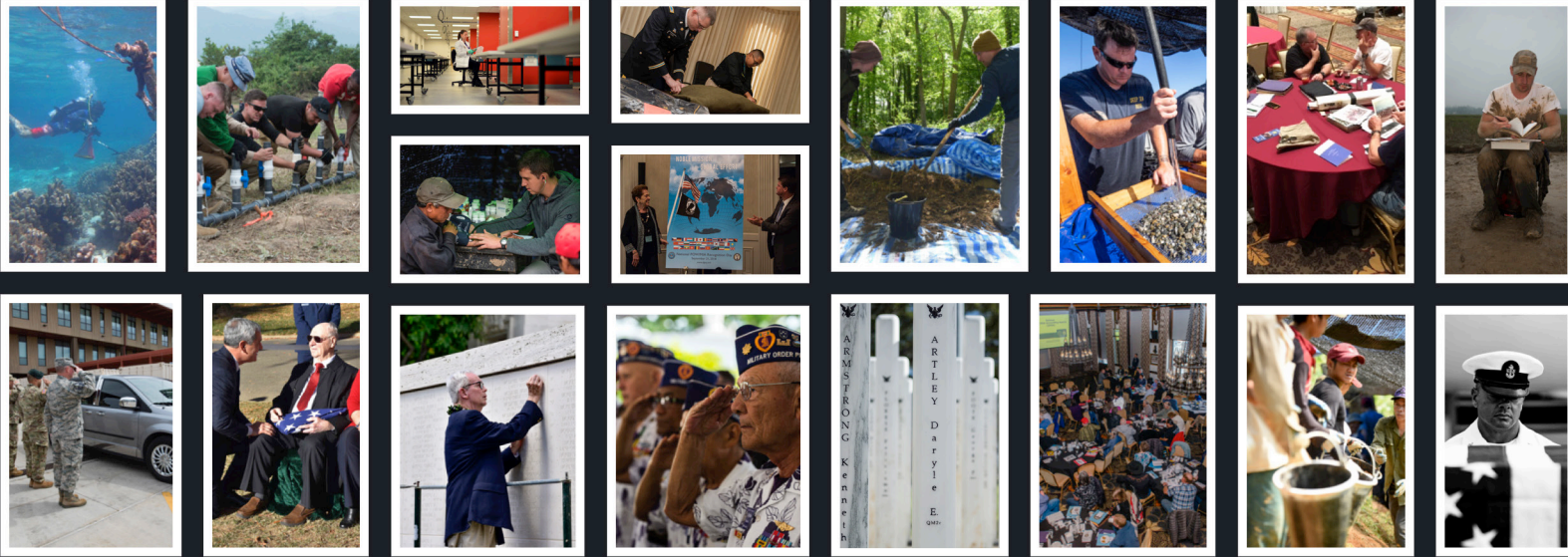
